Update on COVID-19 Case and Mandatory Testing Notice(Tower 1)

The Management Office has just been informed by the Centre for Health Protection (CHP) this afternoon, there is an **overseas confirmed case** of resident of **Tower 1** in The Belcher's summarized as follows: -

1	20/5/2021	0210514	Aged 18, Female, who went to Shenzhen on 5/5/2021. The CHP was notified on 19/5/2021 by the Guangdong health authority that she had been confirmed COVID-19 positive.

In addition, we are notified by Home Affairs Department that residents of Tower 1 of The Belcher's will undergo testing of COVID-19 as mandated by compulsory notice. The Home Affairs Department will directly issue mandatory testing notice to residents of Tower 1.

The Management Office has arranged a series of cleaning and disinfection work at the concerned tower and other public areas (including the lobby and lifts at Main Entrance at Belcher's Street and cargo lift lobbies respectively). Anti-epidemic measures have also been stepped up accordingly. Please refer to the following for details: -

- Cleaning and disinfection work for the door handles of each Tower once every hour during peak hours from 8:00am – 6:00 pm (for non-peak hours: once every 2 hours);
- Cleaning and disinfection work for plastic covers of the lift panels and buttons by 1:49 diluted bleach once every hour;
- Cleaning work for the mailbox area, staircases, and the corridors of typical floors regularly;
- Cleaning work for the trash bins of each tower regularly;
- Cleaning work for the floor drainage in common area;
- Cleaning and disinfection work for common area at Podium level.

Residents are reminded to upkeep the anti-epidemic measures at home. Avoid crowded places and always keep your surgical mask on when going out. We will take appropriate measures in response to the latest condition.

管理處剛於今天下午接獲衛生防護中心通知，本屋苑第1座有一宗外地確診個案，資料如下：

此外，管理處接獲民政事務處的通知，指政府將會向寶翠園第1座居民發出強制檢測公告。屆時，民政事務處會直接向第1座住戶發出正式強制檢測通知書。

管理處已即時安排於上述座數及其他公共設施(包括卑路乍街正門大堂及升降機、貨用升降機大堂及升降機)作徹底消毒，並相應提升防疫措施，有關詳情如下：

- 繁忙時間(08:00-18:00)每小時消毒大門扶手(非繁忙時間為每2小時消毒一次)；
- 每小時於各座升降機用1:49稀釋漂白水清潔按鈕及掣板；
- 每日加強清潔信箱位置、樓層走廊、大廈後樓梯
- 每日分批清洗每座後樓梯垃圾筒；
- 屋苑範圍的各去水渠位置加強清潔；
- 於平台位置進行大型清潔及消毒。

我們謹此提醒住戶做好家中防疫措施，避免前往人多擠逼的地方，外出時須時刻佩帶外科口罩。
